Biographical sketch

Donald Wallace Munro (1916-1998) was born 8 April 1916 in Regina. He attended the University of British Columbia (B.A. Honours French, 1938), Sorbonne (1939), and the University of Toronto (M.A. Political Science, 1946). He taught at Coquitlam Junior High School (1939-40) before serving with the RCAF as a navigator and instructor from 1940-1945 at No. 4 Bomber and Gunnery School, RCAF Fingal. In 1944 Munro married Evelyn May Secombe (1903-1993). He worked for the Department of External Affairs, 1946-1965; and from 1967-1969 he served as Ambassador to Costa Rica, Nicaragua, Honduras, El Salvador and Panama. Munro was first elected as a Progressive Conservative to the House of Commons for Esquimalt-Saanich in October 1972. He was re-elected in 1974, 1979 and 1980, but did not run in the 1984 election. During his retirement in Sidney, B.C., Munro continued to follow and contribute to current political debate, and served on the Board of Directors of the University of Victoria Foundation. Munro died 28 July 1998.

Scope and content

Fonds documents Munro's activities as a diplomat and Member of Parliament, personal research interests, and ongoing political concerns, and include correspondence, memoranda, manuscripts and research materials. Research subjects include Abortion, the Canada/Alaska Boundary Dispute, the Canadian Constitution, External Affairs, Eugene Forsey, the Middle-East, the National Debt, Sidney, B.C., and South Africa.

APPRAISAL STATEMENT

Most of the records, when acquired, consisted of Munro's research material. Of particular concern were the numerous newspaper clippings, research notes and materials, and the multiple copies of manuscripts. Many of the clippings were widely syndicated articles about national and international issues (such as the Meech Lake Accord and Apartheid), re-printed in the Victoria Times-Colonist. As this information is readily available, and as the clippings themselves were not annotated, it was decided that these could be discarded. Those clippings kept were limited to local debates and letters-to-the-editor. As Munro realized little renown as a political writer, and since most of his research was neither extensive nor original, his notes, drafts and untitled research materials were discarded. Munro's source material was rarely annotated, yet took up a considerable volume. If such identifiable items were in the holdings of the University of Victoria Libraries or the National Library of Canada, they were noted and discarded - otherwise they were retained. (n.b.: The bibliography of discarded source material is attached). Single copies of each of Munro's self-published manuscripts were kept. When no final version of a manuscript existed, the archivist retained what appeared to be the most complete draft.

The Munro accession also included approximately 30 maps, mostly of the Canadian west-coast, but also of the Great Lakes region, Toronto-Montreal corridor, Middle-East, South America, and Canadian provincial and territorial evolution. The west-coast maps, in paper (some photocopies) and transparency form, were produced by the Canadian Hydrographic Service, the Hydrographic Office of Great Britain, and the U.S. Hydrographic Survey, and were a part of Munro's research on the Canada/Alaska Boundary Dispute. They depicted, in particular, multiple views of the area of Dixon Entrance, north of Graham Island, between Alaska and the Queen Charlotte Islands. Since these were not annotated extensively or written about at any length by Munro, and since these are readily available maps, they were discarded.

These publications were discarded, but are found in the holdings of the University of Victoria Libraries and/or the National Library of Canada.
