### Biographical sketch

Evelyn Hammond was born in 1920 and raised in Swift Current, Saskatchewan, and was inspired by her father, who helped the homeless and unemployed when he could. She moved to Victoria in 1973 and became involved in several groups: Together Against Poverty, Vancouver Island Human Rights Association, Status of Women Action Group. She was also a Court Monitor for Victoria court cases involving violence against women and children. Hammond died in 1996.

## **Scope and content**

Fonds consists of material documenting Hammond's work as a Court Monitor including: clipping files on court cases, filed by date; general clipping files, by subject; and case books arranged by name of offender and date plus an extensive pamphlet collection on family violence and sex crimes. The case books include unidentified court coding, and colour coding.
