Clayoquot Resource Centre fonds

1993-1994

### **Administrative history**

The Clayoquot Resource Centre was established in Victoria, B.C., in 1993 to provide social, economic, and legal support to people arrested in the 1993 Clayoquot blockade. The blockade developed as a strategy to challenge the forestry practices of MacMillan Bloedel in the Clayoquot area. The Centre closed in 1994 after the trials were completed.

### **Scope and content**

Fonds consists of message books, flyers and correspondence, trial lists, reasons for sentencing, trial summaries, arrestee information book, defence strategies, pamphlets, photographs, "Ron McIsaac's historical account of Clayquot Blockade" clippings scrapbook, and photocopies of Crown Authorities for Criminal Contempt of Court trials.
