Records are annual and holographic until 1974, after which monthly account journals appear. The records show that ledgers were computer-processed by outside agencies after July 1978, and possibly before, though no computer printouts exist for 1976-1977. Boxes 13-15 contain the computer-processed ledgers, monthly from August 1978 to May 1981 (Box 13), year-end from 1981/82 to 1985/86 (Box 14), monthly from June 1986 to October 1988 (Box 15).
